**Please review the following rules and regulations governing ANIMATION SUPERCON, and if you have any questions or concerns, please contact us. By signing and returning the resulting contract, you confirm that you have read the following, agree to, and will comply with, all rules and regulations as stated below.**

1. All exhibitors and vendors must submit a signed copy of this contract. It can be emailed to us at [mike@floridasupercon.com](mailto:mike@floridasupercon.com) – mailed to us at Supercon Conventions (P.O. Box 4012, Fort Lauderdale, FL. 33338) or faxed to us at 203.886.2950. No vendor will be allowed to set up without having submitted a signed vendor contract
2. Space and Table Rental: Each space is an 10'x10' pipe and draped booth. Each space comes with (1) 8' foot table, (2) chairs, (1) wastebasket and (2) badges. End Cap/Corner booths come with (2) 8' tables. You may bring additional tables for your booth. As well, additional tables may be rented for \$30 each. Exhibitors will check in at the Exhibitor table of the show upon arrival to receive badges and booth assignment. You may purchase additional dealer badges for \$35. Dealer badges are for dealers only and are not to be resold. Reselling dealer badges is a violation of the terms of this agreement.
3. All booths must be manned at all times. Supercon Conventions will not be held responsible for any issues arising from an unmanned booth during show hours.
4. Vendor/exhibitor tables/spaces must remain intact throughout the hours of the convention and may not be dismantled prior to the closing of the convention. If you begin breakdown prior to 5:00pm on Sunday afternoon you will not be allowed to come back as a dealer at future shows. The show is not over until 6:00pm on Sunday. It is unfair to other dealers and attendees to break down early. If you cannot stay until the end of the show, please do not set up.
5. Assignment of space will be by show management. We will try to accommodate as many special requests as possible.
6. Exhibitors will comply with all local, state and federal laws, and will not hold management liable for any breaches, losses, or damage to themselves or their property. All vendors/exhibitors agree to hold blameless Animation Supercon and all Animation Supercon staff members and workers against any loss, damage, theft, expenses, claims or actions arising from any personal or property damage, loss or theft due to said vendors/exhibitors participation in Animation Supercon.
7. In addition, all vendors/exhibitors acknowledge that Animation Supercon and all Animation Supercon staff members, workers, employees and agents, will NOT provide or maintain insurance coverage for vendors/exhibitors persons or property, and it is their sole responsibility to obtain insurance covering loss.
8. Animation Supercon in no way endorses any vendors/exhibitor's merchandise, exhibits, views, beliefs, or actions. All vendors/exhibitors are deemed to be their own business/entity and in no way reflect the views, beliefs, intentions and/or direction of Animation Supercon. Vendors/exhibitors do not represent Animation Supercon in any way.

9. All merchandise bought or sold at the Animation Supercon is done strictly between vendors/exhibitors and attendees/buyers, Animation Supercon is not party to or responsible in any way for any transactions made between said parties
10. All adult materials must be either behind the table or, if displayed on a table or display rack bagged or covered so that minors may not open it. Any adult material containing nudity must be covered in accordance with local and state laws. Exhibitor agrees not to sell any adult materials to minors.
11. State tax is the responsibility of the vendor to collect according to state laws.
12. No Bootleg DVD's or CD's. Representatives from various studios will be at the convention. Anyone selling unauthorized merchandise that infringes upon their copyright or licensing agreements (or any other studios) will be asked to leave the show. No refunds will be given if you break this rule and are asked to leave.
13. No outside food and beverage allowed. We have an exclusive contract for the show to be supplied with Japanese snacks, and that deal does not allow for additional food/beverage vendors. Anyone who attempts to sell food and beverage at the show will be asked to remove the items from their booth. Repeat offenders may be asked to leave the show, with no refund given.
14. No additional vendors whose main business is the sale of swords, knives or other misc. sharp weapons. Any vendor who attempts to circumvent this rule and attempts to set up under false pretenses may be asked to leave the show, with no refund given.
15. Exhibitors who renew for the following year on Sunday of the event each year will be "grandfathered in" and pay today's price. Not Transferable
16. Dealers will be supplied with **two dealer badges for each booth** purchased. Additional badges may be purchased in advance for \$35. Dealer badges must be worn at all times by any person working at a booth. Badges may not be sold, loaned, or otherwise transferred to persons who are not working for you. Dealer badges do not allow access to special functions that require a separate admission price (i.e. celebrity dinners, tournaments). Animation Supercon requires that all vendors not only wear a vendor badge, but a general admission bracelet as well. This is done to prevent fraud as well as limit the amount of people gaining admittance to the show off of one vendor badge. This may be inconvenient, but we do this to ensure that we will be able to host future events. We depend on admission monies to pay for the show. Without this money, we're out of business, and you have one less viable show to sell your wares. If you are with a production house, animation/comic studio, or other part of the industry and wish to have more badges for your industry (i.e. non-retail personnel), please contact our Executive Director, and the appropriate actions will be taken.

17. Electrical service for your booth is available for \$58 from Animation Supercon in advance. At the show, Electrical services will be available from the convention center and may be a higher rate.
18. No exhibit may block or interfere with other exhibits or with the aisle space.
19. Any damage caused to the building or its furnishings by the Exhibitor are the sole responsibility of the Exhibitor.
20. Exhibitors must stay within the boundaries of their exhibit space. Do not block aisle walkways.
21. Should you (the dealer) find that you are not able to attend Florida Supercon and have already paid for your booth(s), the policy is as follows:  
50% refund if cancelled prior to August 15, 2009  
**\*\*NOTE\*\* ANY CANCELLATION AFTER AUGUST 15, 2009 WILL RESULT IN THE FORFEITURE OF ANY AND ALL PAYMENTS MADE TO SUPERCON CONVENTIONS.**
